

**SPECIAL POWER OF ATTORNEY**  
(Emergency Medical Care and Treatment)

KNOW ALL MEN BY THESE PRESENTS: That I, \_\_\_\_\_, a resident of \_\_\_\_\_, now (serving/ accompanying) the Armed Forces of the United States as (family member/active duty military/ DOD civilian) SSN:\_\_\_\_\_, presently serving overseas at U.S. Naval Air Facility, Atsugi, Japan, have made constituted and appointed, and by these presents do make, constitute and appoint any Medical Doctor serving in any Medical Facilities, my true and lawful attorney for me in my name, place and stead, and for my use and benefit and as my act and deed, to do and execute, or to concur with persons jointly interested with myself therein in the doing executing of all or any of the acts, deeds, things and purposes which are hereinafter expressed.

1. To authorize, permit and consent to such emergency medical care and treatment, whether inpatient or outpatient, or both, for: \_\_\_\_\_ DOB: \_\_\_\_\_, as may be necessary or advisable in the opinion of competent medical authorities if the undersigned and/or undersigned's spouse ca not be contacted for prior approval of such use.

2. To sign, seal, execute and deliver any application, request, receipt, release, and any and all other papers or documents necessary to accomplish the above.

3. To do any and all other acts which my said attorney feels necessary to contribute to the care, health safety and well-being of my said child under such emergency medical conditions. I do also constitute and appoint any adult (i.e., person over 21 years of age) caring for my child, my true and lawful attorney to transport my child to any Medical Facilities should an emergency situation arise requiring medical treatment of said child when myself or my spouse cannot be contacted, and to contact for medical treatment at civilian medical facilities in my name.

Giving and granting to my said attorneys full power and authority to do and perform all and every act and thing whatsoever requisite and necessary to be done in and about the premises, which for this power I do hereby expressly declare shall be strictly construed as limited to those matters hereinbefore specifically set forth, as fully to all intents and purposes as I might or could do if personally present at the doing thereof, hereby ratifying and confirming all that my said attorney may or shall lawfully do or cause to be done by virtue hereof.

The power given in the premises to my named attorney shall, for the purpose of initiating any new transaction or act, terminate, cease, lapse, as of \_\_\_\_\_.
